#### **FORECAST FOR 2025-26 FINANCIAL YEAR**

A forecast for the 2024-25 FY is give on Page 4. A surplus of about £1100 is forecast. This forecast assumes that current levels of giving will continue.

Total future costs for LAC 53 and 54 are given on Page 5. The majority of the cost for LAC#54 will not be incurred until the 2026-7 Financial Year.

#### RISKS

The major (existential) risks to LAC are:

- Lack of volunteers coming forward to undertake roles, without which, LAC would not be able to continue;
- The Bishop withdrawing consent for LAC to operate, which would result in its closure;
- A sudden and extreme drop in donations, which would result in our having weekends much less frequently.
